#### Let's Hear from Connecticut Voters with Disabilities

**Check Your Polling Place(s) for Accessibility** 

- Two Accessible Parking Spaces?
- Path of Travel 36" wide and free of cracks and grates over 1/2" wide?
- No stairs!
- Doors open with 8 lbs of force for exterior doors and 5 lbs of force for interior doors?
- Door handles able to be opened with closed fist?

#### **Hire Poll Workers with Disabilities**

- Representative of community.
- Good source of poll workers.



- **Train All Poll Workers on the Ballot Marking Device** 
  - Have poll workers try the ballot marking device during training.
  - Encourage poll workers to vote using the ballot marking device.
  - Train poll workers to call it the ballot marking device not the "handicapped machine"
  - Ballot Marking System is for anyone to use!

Ensure the Ballot Marking Device is Set Up and Ready to Use at 6:00 AM

- At polling place(s).
- At the EDR location.
- Private Area so others can't see the screen.
- Use a privacy screen.

**Treat All Voters with Disabilities with Respect** 

- Talk directly to the voter, not the companion.
- Use person-first language.
- Do not make assumptions about capacity to vote based on your perceptions about a voter's disability.

Allow a Voter with a Disability to move to the front of the line if disability prevents them from standing and waiting.



Welcome Service Animals (Dogs or Miniature Horses)

- Can only ask two questions:
  - 1. Is the animal required because of a disability?
  - 2. What tasks is the animal trained to perform?
- Do not pet or distract a service animal It is working
  - May be dangerous for the handler
  - Always ask permission to pet, but do not take offense if the answer is no.

#### Don't Assume – Ask

- Offer assistance to voters with disabilities but don't assume what the person needs it.
- If the voter declines the assistance, don't force it.
- People with disabilities will tell you what they need and how you can help.

Have accessible booths for voters who use wheelchairs.

- The ballot marking system should also be on an accessible table.
- Access path the booths.
- Knee clearance of "27"
- Space in front of table 30"



Allow a Voter with a Disability to Receive Assistance from a person of their choice.

- Exceptions employer, union, candidate on ballot.
- Can't require them to accept assistance.
- Can't require the assistance of a
- poll worker.



## Transgender Considerations

- Increasingly transgender voters have been harassed or challenged at the polls because their gender expression or name differs from the ID presented to poll workers.
- Creates fear of being challenged at the polls
- Potentially suppresses the vote.

Potential Situation – A person approaches the checker line and presents as a gender identity that does not match their ID.

- Poll workers should not be distracted or comment on the voter's appearance when evaluating the ID.
- Do not ask personal questions may be out of curiosity and is not appropriate.

Transgender voters are doing nothing wrong and are not trying to deceive you.

They have a right to vote like anyone else.

Responsibility of the poll workers and election officials to ensure that everyone can vote without embarrassment or hassle.



- Sometimes a transgender voter is unable to get their official documentation changed due to a number of factors such as cost or timing.
  - This is not illegal.
- If the voter data matches the ID they supplied, the voter has the right to vote.
- If ID does not match and the poll worker has concerns, quietly contact the Moderator.
