Lisbeth Becker summarized discussion with Tom Miano on upcoming changes to election systems.

- Aiming for July 2022 completion of CT Voter Registration System upgrade
  - Working on project plan and includes looking at what is currently available and if needs of CT would fit into existing programs with alterations or start from scratch
    - Online Registration changes would be tied into CVRS changes
- Would tie changes to Election Management System with new tabulator – no potential date for project at this time.
- Elections Project Manager starting June 1, 2021. Reports to Ted Bromley and Tom Miano. Hopefully will be introduced at ROVAC Virtual Spring Conference

#### Turned meeting over to Sheena

- She is waiting on Rick May
- Mid-June schedule start date
- Describes CITRIX as a security app
- Active Directory – set up credentials (goes to each person to have separate email account)
- New machines added – Sheena does install

CVRS runs on Internet Explorer but DAS/BEST is migrating to Microsoft Edge

Need to address impact of Citrix on SSVR. None really just adds requirement for another password.

Completion date projected for June 2022

Jim Bromer asked if CVRS is on state server; IP route changes

- Installation time frame projected at 30 minutes at each site
- Several folks said they did not receive attachments with the excel spreadsheet to identify number of users
- Sheena said she would resend the email with the attachments
