- Canvass –DO NOT SEND (canvass) CVR notices before Primary Day. Send CVRs between April 26 and May 1. Remember to include ERIC lists to canvass
- NOTE: CVRs may be sent anytime for P.O. returned Acceptance notices.
- March 28 training for registrars & deputies Aqua Turf in Southington 8:30am
- High School voter registration sessions – before Pres. Primary recommended
- April 5-21 Notice of Acceptance/Rejection to be sent on day of receipt of application by mail.
- April 12 Mandatory Enrollment Session– 2hours minimum (noon – 9pm)
- April 21 Deadline for Mail-In & Online Voter Registrations
- April 25 Noon, Voter Registration Session
  - \*Noon - Deadline for In-Person Voter Registrations
  - \*End of Day, Deadline for Servicemen
- April 26 to May 1 – Mail out Canvass CVRs
- April 26 Presidential Preference Primary
  - One tabulator acceptable for both Dem & Rep primary ballots
- May 9 Party Transfer Deadline (for Aug. Primary)
- June 7 Mandatory Office Hours 1 – 4pm – Primary Petition Filing
