Ways & Means: Sue Burnham reported we Oraised \$1,259 from the 50/50 raffle and \$2,282 from the county baskets for a total of \$3,542 for the Judi Boudreau scholarship.

It did include the registrars could be moderators during early voting. \$1,000,000 was allocated to covering early voting. Sullivan & LeShane will be putting together an update on the session.

Technology – Lisbeth Becker (Glastonbury) reported the committee met during the conference. They discussed the new total vote system. Some towns have been selected to pilot the program. Ann Kilby is reviewing the RFP and will put it in chart form. The issue with Total Vote is that we are 169 towns and not county base. After the Presidential election there will be lots of training on the KNOWINK system. SOTS Owill send out the issues which we will have to deal with such as suppressed addresses. The selection of the tabulator has been made but not announced.
